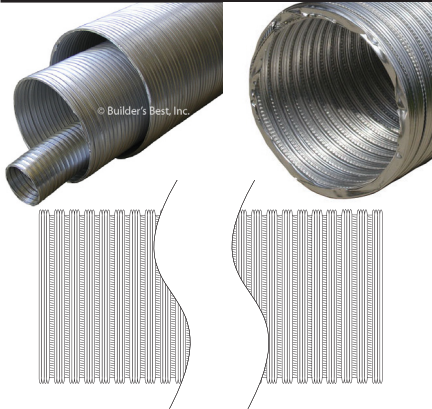

Our design allows for better stretching and bending characteristics. This helps eliminate flattening on the outside radius of a bend thus preventing restricted airflow

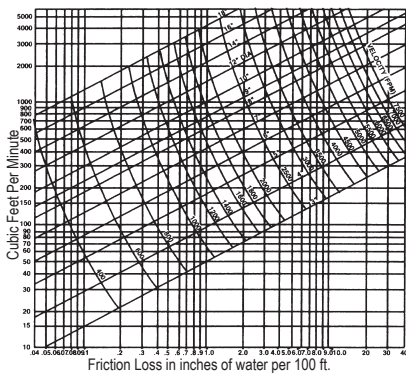
